The Top 50 Firms For Minority Equity Partners

Law360, New York (May 15, 2016, 10:16 AM ET) -- While equity partnerships at U.S. law firms remain overwhelmingly white, 50 firms have widened the playing field for attorneys of color, according to Law360 data.

These 50 firms have the highest percentage of minority equity partners out of the 308 U.S.-based law firms that disclosed their equity partner data by race to Law360 as part of the 2016 Diversity Snapshot.

At these firms, 15.2 percent of equity partners identified as a minority, as opposed to only 7.58 percent at all firms surveyed. That number shoots up to at least 20 percent of equity partners at each of the top 10 firms on this list.

Even though minorities have comprised at least 20 percent of each graduating law school class since 2002, according to the American Bar Association, these firms remain the exception, not the rule. Notably, 35 firms surveyed by Law360 reported having no equity partners of color at all.

By far the least represented minority among those surveyed are black attorneys. For each black equity partner, there are more than 56 white equity partners. Among these 50 firms, that ratio improves — however slightly — to one to 34.

These firms also have a higher percentage of minority attorneys overall, at both the partner and nonpartner levels — 22.1 percent as opposed to 14.7 percent of all firms surveyed — indicating that retaining talent is easier when minority attorneys see that they have a pathway to partnership, and that the firm's highest ranks are not held exclusively by white men.

Leading the top are Texas boutique Ahmad Zavitsanos Anaipakos Alavi & Mensing PC, Southern California-based Atkinson Andelson Loya Ruud & Romo and D.C. intellectual property attorneys Sughrue Mion PLLC. The 50 are a blend of small and midsize firms and BigLaw alike, indicating that diversity is a reachable goal regardless of firm size.
