(November 19, 2024)


On this date, the undersigned issued an initial determination concerning Complainants' motion for temporary relief in the above-captioned matter.<sup>1</sup> For the reasons discussed therein, it is the undersigned's initial determination that Complainants' motion for temporary relief is denied. Complainants have not shown likelihood of success on the merits with respect to infringement of asserted claims 1, 4, 9, and 12 of U.S. Patent No. 11,925,202; or with respect to invalidity of the asserted claims. In addition, Complainants have not persuasively shown irreparable harm in the event a temporary exclusion order is not issued.

Notice of the initial determination is being served on the other agencies listed in 19 C.F.R. § 210.50(a)(2). Pursuant to 19 C.F.R. § 210.66(d) "[t]hose agencies will be given 10 calendar days from the date of service of the notice to file comments on the initial determination."
